

## PRECONDITIONED ITERATIVE METHODS FOR SOLVING TOEPLITZ-PLUS-HANKEL SYSTEMS\*

**Abstract.** The use of preconditioned iterative methods to solve a system of equations with a Toeplitz-plus-Hankel coefficient matrix is studied. A new preconditioner suitable for Toeplitz-plus-Hankel matrices is proposed, and the spectral properties of preconditioned rational Toeplitz-plus-Hankel matrices are examined. It is shown that the eigenvalues of the preconditioned matrix are clustered around unity, except for a finite number of outliers, depending on the orders of the rational generating functions, and the clustering radius is proportional to the magnitude of the last elements in Toeplitz and Hankel matrices. With the spectral regularities, an  $N \times N$  rational Toeplitz-plus-Hankel system can be solved by preconditioned iterative methods with  $O(N \log N)$  operations. Numerical experiments are given to demonstrate the efficiency of the proposed preconditioner.

**Key words.** Toeplitz-plus-Hankel, preconditioned iterative method, rational generating function

**1. Introduction.** The systems of linear equations with Toeplitz, Hankel, and Toeplitz-plus-Hankel coefficient matrices arise in many signal processing applications. For example, the inverse scattering problem can be formulated as Toeplitz, Hankel, and Toeplitz-plus-Hankel systems of equations, which were done by Krein [20], Agranovich and Marchenko [1], and Gelfand and Levitan [14], respectively. (For more recent work, we refer to [3], [4].) By exploiting the special structures of Toeplitz or Hankel matrices, an  $N \times N$  system of equations can be solved by fast direct methods based on the Levinson or Schur algorithm with  $O(N^2)$  operations [11], [12], [13], [21]. Direct algorithms for inverting  $N \times N$  Toeplitz-plus-Hankel matrices with  $O(N^2)$  complexity have also been derived [16], [17], [27]. Although the computational complexity of these fast algorithms is lower than that of the Gaussian elimination with pivoting, i.e.,  $O(N^3)$ , their stability is not guaranteed when applied to indefinite or nonsymmetric matrices [5], [10]. In this paper, we propose to use preconditioned iterative methods to solve Toeplitz-plus-Hankel systems, which have a low computational complexity and a stable convergence performance.

Toeplitz preconditioners in circulant or skew-circulant matrix form have been proposed and analyzed by many researchers [7], [9], [19], [22], [30], [32]. It was shown by Chan and Strang [8] that, for a large class of symmetric Toeplitz matrices, the eigenvalues of preconditioned matrices are clustered around unity and the preconditioned iterative method converges at a superlinear rate. For Toeplitz matrices generated by rational functions, an even stronger convergence result was obtained by Trefethen [31] and the authors [24], [25]. That is, the preconditioned iterative method converges in a finite number of iterations independent of the problem size  $N$ . Consequently, a rational Toeplitz system can be solved with  $O(N \log N)$  operations. In addition to low computational complexity, preconditioned iterative methods demonstrate a very stable convergence behavior. Since a Hankel system can be transformed to a Toeplitz system by reversing the order of the linear equations, the same results also hold for

Hankel systems.

The inverse scattering problem is often formulated as two waves propagating in opposite directions. The discrete version of the formulation can be naturally expressed as an  $N \times N$  Toeplitz-plus-Hankel system  $A\mathbf{x} = \mathbf{b}$ , where  $A$  is the sum of a Toeplitz matrix  $T$  and a Hankel matrix  $H$  with elements  $T_{i,j} = t_{i-j}$  and  $H_{i,j} = h_{N+1-(i+j)}$  [2], [3], [4], [6], [26]. The idea of constructing a Toeplitz-plus-Hankel preconditioner can be simply stated as follows. Let  $J$  be an  $N \times N$  matrix which has ones along the secondary diagonal and zeros elsewhere (i.e.,  $J_{i,j} = 1$  if  $i + j = N + 1$  and  $J_{i,j} = 0$  if  $i + j \neq N + 1$ ). We can easily verify that the product of  $J$  and  $H$  gives a Toeplitz matrix  $T_H = JH$  with elements  $[T_H]_{i,j} = h_{i-j}$ , and that the Toeplitz-plus-Hankel matrix can be expressed as  $A = T + H = T + JT_H$ . Now, given preconditioners  $K_T$  and  $K_H$  for Toeplitz matrices  $T$  and  $T_H$ , we propose to use  $P = K_T + JK_H$  as a preconditioner for matrix  $A$ .

To solve the Toeplitz-plus-Hankel system  $A\mathbf{x} = \mathbf{b}$  with preconditioner  $P$ , two major computations required at each iteration are the matrix-vector products  $A\mathbf{v}$  and  $P^{-1}\mathbf{v}$  with an arbitrary vector  $\mathbf{v}$ . The operation  $A\mathbf{v}$  can be performed effectively via fast Fourier transform (FFT) with  $O(N \log N)$  operations, since both  $T\mathbf{v}$  and  $H\mathbf{v}$  can be embedded in a  $2N \times 2N$  circulant matrix-vector product. To implement the preconditioning step  $P\mathbf{z} = \mathbf{v}$ , we relate it to an equivalent  $N \times N$  circulant system which can be inverted via FFT with  $O(N \log N)$  operations. Consequently, the computational complexity for each iteration is  $O(N \log N)$ .

In the context of inverse scattering, the generating sequences of Toeplitz and Hankel matrices can be selected with great flexibility. Thus, we focus on the case that the sequences  $\{t_n\}$  and  $\{h_n\}$  are generated, respectively, by rational functions of orders  $(\alpha_T, \beta_T, \gamma_T, \delta_T)$  and  $(\alpha_H, \beta_H, \gamma_H, \delta_H)$  (see the definition in §3.1) and study the spectral properties of preconditioned matrices. The eigenvalues of  $P^{-1}A$  are classified into two classes, i.e., the outliers and the clustered eigenvalues. Then the preconditioned matrix has the following two spectral properties: (1) The number of outliers is bounded by a constant which depends on the orders of the rational generating functions; and (2) the clustered eigenvalues are confined in a disk centered at unity with radius  $\epsilon$  proportional to  $O(|t_N| + |t_{-N}| + |h_N| + |h_{-N}|)$ . With the above spectral properties, various preconditioned iterative methods, including CGN (the Conjugate Gradient iteration applied to the Normal equations) [18], GMRES (the Generalized Minimal Residual) [28], and CGS (the Conjugate Gradient Square) [29], can be effectively applied. It turns out that a rational Toeplitz-plus-Hankel system can be solved in a finite number of iterations independent of the problem size  $N$  so that the total operations required are  $O(N \log N)$ . Besides, preconditioned iterative methods are highly parallelizable due to the parallelism provided by FFT. The time complexity can be reduced to  $O(\log N)$  if  $O(N)$  processors are used.

This paper is organized as follows. We discuss the construction and the computational complexity of preconditioner  $P$  for Toeplitz-plus-Hankel matrices in §2. The spectral properties of the preconditioner and the preconditioned rational Toeplitz-plus-Hankel matrix are examined in §3. Numerical experiments are given in §4 to illustrate our theoretical study.

## 2. The Toeplitz-plus-Hankel preconditioner.

**2.1. Construction of the preconditioner.** Consider the  $N \times N$  Toeplitz-plus-Hankel system

$$(2.1) \quad A\mathbf{x} = \mathbf{b}, \quad A = T + H,$$

where  $T$  and  $H$  are given Toeplitz and Hankel matrices with elements  $T_{i,j} = t_{i-j}$  and  $H_{i,j} = h_{N+1-(i+j)}$ . With the special structures of Toeplitz and Hankel matrices, a Hankel matrix  $H$  can be transformed to a Toeplitz matrix by premultiplying (or postmultiplying) it with

$$J = \begin{bmatrix} 0 & 0 & \cdot & 0 & 1 \\ 0 & \cdot & 0 & 1 & 0 \\ \cdot & \cdot & \cdot & \cdot & \cdot \\ 0 & 1 & 0 & \cdot & 0 \\ 1 & 0 & \cdot & 0 & 0 \end{bmatrix},$$

which is known as the time-reversal operator. It is clear that  $T_H = JH$  is a Toeplitz matrix with elements  $[T_H]_{i,j} = h_{i-j}$  and that  $JT_H = J^2H = H$ . Thus, (2.1) can also be written as

$$(2.2) \quad (T + JT_H)\mathbf{x} = \mathbf{b},$$

where  $T$  and  $T_H$  are  $N \times N$  Toeplitz matrices generated by the sequences  $\{t_n\}$  and  $\{h_n\}$ , respectively.

The procedure to construct a circulant preconditioner for Toeplitz matrix

$$T = \begin{bmatrix} t_0 & t_{-1} & \cdot & t_{-(N-2)} & t_{-(N-1)} \\ t_1 & t_0 & t_{-1} & \cdot & t_{-(N-2)} \\ \cdot & t_1 & t_0 & \cdot & \cdot \\ t_{N-2} & \cdot & \cdot & \cdot & t_{-1} \\ t_{N-1} & t_{N-2} & \cdot & t_1 & t_0 \end{bmatrix}$$

is summarized as follows [22]. We are motivated by the observation that we can solve the  $2N \times 2N$  circulant system effectively,

$$(2.3) \quad R_T \begin{bmatrix} \mathbf{x} \\ \mathbf{x} \end{bmatrix} = \begin{bmatrix} \mathbf{b} \\ \mathbf{b} \end{bmatrix}, \quad R_T = \begin{bmatrix} T & \Delta T \\ \Delta T & T \end{bmatrix},$$

where  $\Delta T$  is determined by the elements of  $T$  to make  $R_T$  circulant, i.e.,

$$\Delta T = \begin{bmatrix} 0 & t_{N-1} & \cdot & t_2 & t_1 \\ t_{-(N-1)} & 0 & t_{N-1} & \cdot & t_2 \\ \cdot & t_{-(N-1)} & 0 & \cdot & \cdot \\ t_{-2} & \cdot & \cdot & \cdot & t_{N-1} \\ t_{-1} & t_{-2} & \cdot & t_{-(N-1)} & 0 \end{bmatrix}.$$

Since (2.3) is equivalent to

$$(2.4) \quad K_T \mathbf{x} = \mathbf{b}, \quad K_T = T + \Delta T,$$

we choose the circulant matrix  $K_T$  as a preconditioner for  $T$ . Similarly, we have the circulant preconditioner  $K_H = T_H + \Delta T_H$  for Toeplitz matrix  $T_H$ . Then, with respect to (2.2), we propose to use

$$(2.5) \quad P = K_T + JK_H$$

as a preconditioner for the Toeplitz-plus-Hankel matrix  $A$ .

**2.2. Computational complexity of the preconditioner.** To solve the Toeplitz-plus-Hankel system  $\mathbf{Ax} = \mathbf{b}$  with preconditioner  $P$ , two major computations required at each iteration are the matrix-vector products  $A\mathbf{v}$  and  $P^{-1}\mathbf{v}$  with an arbitrary vector  $\mathbf{v}$ . We show below that they both can be achieved with  $O(N \log N)$  operations. Since other operations involved are vector additions or inner products whose complexity is proportional to  $O(N)$ , the total computational complexity per iteration is  $O(N \log N)$ .

The  $N \times N$  Toeplitz matrix-vector product  $T\mathbf{v}$  can be embedded in the  $2N \times 2N$  circulant matrix-vector product

$$\begin{bmatrix} T & \Delta T \\ \Delta T & T \end{bmatrix} \begin{bmatrix} \mathbf{v} \\ \mathbf{0} \end{bmatrix} = \begin{bmatrix} T\mathbf{v} \\ \Delta T\mathbf{v} \end{bmatrix},$$

so that it can be effectively computed via FFT with  $O(N \log N)$  operations. Premultiplying  $J$  to a vector  $\mathbf{v}$  corresponds to the reverse of the order of the elements in  $\mathbf{v}$ . Thus, the Toeplitz-plus-Hankel matrix-vector product

$$A\mathbf{v} = T\mathbf{v} + JT_H\mathbf{v}$$

can also be achieved with  $O(N \log N)$  operations.

With the equality  $J^2 = I$  and (2.5), we have

$$(2.6) \quad P\mathbf{z} = K_T\mathbf{z} + JK_HJJ\mathbf{z} = \mathbf{v},$$

which is equivalent to

$$(2.7) \quad JP\mathbf{z} = JK_TJJ\mathbf{z} + K_H\mathbf{z} = J\mathbf{v}.$$

Since  $K_T$  and  $K_H$  are circulant,  $JK_TJ = K_T^T$ ,  $JK_HJ = K_H^T$  and  $K_T$ , and  $K_H$  commute. By multiplying (2.6) with  $K_T^T$  and (2.7) with  $K_H^T$ , we can write the difference between the two resulting equations as

$$(2.8) \quad (K_T^TK_T - K_H^TK_H)\mathbf{z} = K_T^T\mathbf{v} - K_H^TJ\mathbf{v}.$$

Thus, the solution of  $\mathbf{z} = P^{-1}\mathbf{v}$  can also be determined from (2.8). It is easy to verify that  $K_T^TK_T - K_H^TK_H$  is circulant and can be diagonalized with Fourier functions. Consequently,  $P^{-1}\mathbf{v}$  can be solved effectively via FFT with  $O(N \log N)$  complexity. Note also that the Fourier coefficients  $\hat{v}_k$  and  $\hat{w}_k$  of the vectors  $\mathbf{v}$  and  $\mathbf{w} = J\mathbf{v}$  are related via

$$\hat{w}_k = \hat{v}_{-k \bmod N}, \quad 0 \leq k \leq N - 1,$$

which means that only a FFT and an inverse FFT are needed in solving (2.8), given the eigenvalues of  $K_T$  and  $K_H$ .

In conclusion, the total computational complexity inside each iteration of the preconditioned iterative methods is only  $O(N \log N)$ . Besides, the preconditioned iterative methods are highly parallelizable due to the parallelism provided by FFT, and the time complexity can be reduced to  $O(\log N)$  if  $O(N)$  processors are used.

**3. Analysis of the preconditioner.** We assume that Toeplitz matrix  $T$  and Hankel matrix  $H$  are generated by real sequences  $\{t_n\}$  and  $\{h_n\}$  satisfying

$$(3.1) \quad \sum_{-\infty}^{\infty} |t_n| \leq B_T < \infty, \quad \sum_{-\infty}^{\infty} |h_n| \leq B_H < \infty.$$

The circulant matrices  $K_T$ ,  $K_T^T$ ,  $K_H$ , and  $K_H^T$  share the same Fourier functions as their eigenvectors with eigenvalues

$$\lambda_k(K_T) = \lambda_k^*(K_T^T) = \sum_{n=-(N-1)}^{N-1} t_n e^{-j(2\pi kn/N)},$$

$$\lambda_k(K_H) = \lambda_k^*(K_H^T) = \sum_{n=-(N-1)}^{N-1} h_n e^{-j(2\pi kn/N)},$$

where  $k = 0, 1, \dots, N-1$ , and  $\lambda_k^*$  denotes the complex conjugate of  $\lambda_k$ . We also assume that

$$(3.2) \quad ||\lambda_k(K_T)|^2 - |\lambda_k(K_H)|^2| \geq \mu > 0, \quad 0 \leq k \leq N-1,$$

where  $\mu$  is a constant independent of  $N$ . We will show in Theorem 1 that the above condition implies the invertibility of the preconditioner  $P$ .

The generating functions of  $T$  and  $T_H$  are defined as

$$T(z) = \sum_{n=-\infty}^{\infty} t_n z^{-n}, \quad H(z) = \sum_{n=-\infty}^{\infty} h_n z^{-n}.$$

We focus on the case

$$(3.3a) \quad T(z) = \frac{A_T(z^{-1})}{B_T(z^{-1})} + \frac{C_T(z)}{D_T(z)}, \quad H(z) = \frac{A_H(z^{-1})}{B_H(z^{-1})} + \frac{C_H(z)}{D_H(z)},$$

where  $T(z)$  is a rational function of order  $(\alpha_T, \beta_T, \gamma_T, \delta_T)$ , i.e.,

$$(3.3b) \quad \begin{aligned} A_T(z^{-1}) &= \sum_{i=0}^{\alpha_T} a_{T,i} z^{-i}, & C_T(z) &= \sum_{i=0}^{\gamma_T} c_{T,i} z^i, \\ B_T(z^{-1}) &= \sum_{i=0}^{\beta_T} b_{T,i} z^{-i}, & D_T(z) &= \sum_{i=0}^{\delta_T} d_{T,i} z^i, \end{aligned}$$

with  $a_{T,i}, \alpha_T b_{T,i}, \gamma_T c_{T,i}, \delta_T d_{T,i} \neq 0$ ,  $b_{T,0} = 1$ ,  $d_{T,0} = 1$ , and polynomials  $A_T(z^{-1})$  and  $B_T(z^{-1})$  (or  $C_T(z^{-1})$  and  $D_T(z^{-1})$ ) have no common factors. Similarly,  $H(z)$  is a rational function of order  $(\alpha_H, \beta_H, \gamma_H, \delta_H)$ . For convenience, we let

$$(3.4) \quad \begin{aligned} r_T &= \max(\alpha_T, \beta_T), & s_T &= \max(\gamma_T, \delta_T), \\ r_H &= \max(\alpha_H, \beta_H), & s_H &= \max(\gamma_H, \delta_H). \end{aligned}$$

Note that (3.1) implies that all zeros of  $B_T(z^{-1})$  and  $B_H(z^{-1})$  ( $D_T(z)$  and  $D_H(z)$ ) are inside (outside) the unit circle. By applying the isomorphism between the ring of the power series and the ring of semi-infinite lower (or upper) triangular Toeplitz matrices, with respect to  $T(z)$  and  $H(z)$  given in (3.3), we have

$$(3.5) \quad T = L_{A,T} L_{B,T}^{-1} + U_{C,T} U_{D,T}^{-1}, \quad T_H = L_{A,H} L_{B,H}^{-1} + U_{C,H} U_{D,H}^{-1},$$

where  $L_{A,T}$  and  $L_{B,T}$  ( $U_{C,T}$  and  $U_{D,T}$ ) are  $N \times N$  lower (upper) triangular Toeplitz matrices generated by  $A_T(z^{-1})$  and  $B_T(z^{-1})$  ( $C_T(z)$  and  $D_T(z)$ ), respectively. The  $L_{A,H}$ ,  $L_{B,H}$ ,  $U_{C,H}$ , and  $U_{D,H}$  are similarly defined with respect to  $H(z)$ .

**3.1. Invertibility of the preconditioner.** With condition (3.2), in the following theorem we prove that  $P^{-1}$  exists.

**THEOREM 1.** *Let  $T$  and  $H$  be  $N \times N$  Toeplitz and Hankel matrices satisfying (3.2). Then,  $\|P^{-1}\|_2$  is bounded for any given  $N$ .*

*Proof.* Recall from (2.8) that  $Pz = v$  is equivalent to

$$(3.6) \quad (K_T^T K_T - K_H^T K_H)z = (K_T^T - K_H^T J)v.$$

For any given  $N$ ,  $\|K_T^T\|_1$  and  $\|K_T^T\|_\infty$  are both bounded. As a consequence,  $\|K_T^T\|_2$  is also bounded. Similar results hold for  $K_H^T$ . Thus, the right-hand side of (3.6) is bounded. With condition (3.2), the magnitude of any eigenvalue of  $K_T^T K_T - K_H^T K_H$  is also bounded by

$$|\lambda_k(K_T^T K_T - K_H^T K_H)| = | |\lambda_k(K_T)|^2 - |\lambda_k(K_H)|^2 | \geq \mu > 0.$$

Therefore,  $\|P^{-1}\|_2$  is bounded and the preconditioner  $P$  is invertible.  $\square$

**3.2. The number of outliers of  $P^{-1}A$ .** Since

$$\lambda(P^{-1}A) = 1 - \lambda(P^{-1}\Delta A),$$

the eigenvalues of  $P^{-1}A$  clustered around one correspond to those of  $P^{-1}\Delta A$  clustered around zero. According to the definitions of  $K_T$  and  $K_H$ , the difference matrix  $\Delta A = P - A$  can be written as

$$(3.7) \quad \Delta A = \Delta T + J\Delta T_H.$$

Based on the structures of  $\Delta T$  and  $\Delta T_H$ , we will decompose the  $\Delta A$  into the sum of a low rank matrix  $\Delta F$  and a perturbation matrix, in which the rank of  $\Delta F$  does not change with  $N$  and all matrix norms of the perturbation matrix converge to zero for asymptotically large  $N$ . Then, we define the outliers of  $P^{-1}\Delta A$  as the eigenvalues of  $P^{-1}\Delta A$  corresponding to the nonzero eigenvalues of  $P^{-1}\Delta F$  with perturbation. Since there is a one-to-one correspondence between the eigenvalues of  $P^{-1}\Delta A$  and  $P^{-1}A$ , the outliers of  $P^{-1}A$  can also be defined. A direct consequence of this definition is that the outliers of  $P^{-1}A$  do not converge to unity for asymptotically large  $N$ . Besides, the number of outliers of  $P^{-1}A$  is fixed and equivalent to the rank of  $\Delta F$ . The rank of  $\Delta F$  will be examined in this subsection so that the number of the outliers is determined. The perturbation theory of eigenvalues will then be used in §3.3 to study the clustering radius of the clustered eigenvalues.

The analysis for the number of outliers proceeds as follows.

*Step 1.* Construct a low rank matrix  $\Delta F$  based on the recursion in  $t_n$  and  $h_n$  described in Lemma 1.

*Step 2.* Show that  $\Delta F$  is asymptotically equivalent to  $\Delta A$  (Lemma 2).

*Step 3.* Establish an upper bound for the rank of  $\Delta F$ , which is equal to the number of outliers of  $P^{-1}A$  (Theorem 2).

**LEMMA 1.** *The sequences  $t_n$  and  $h_n$  generated by (3.3) that satisfy condition (3.1) follow the recursions*

$$(3.8) \quad \begin{aligned} t_{n+1} &= -(b_{T,1}t_n + b_{T,2}t_{n-1} + \dots + b_{T,\beta_T}t_{n-\beta_T+1}), & n \geq r_T, \\ t_{n-1} &= -(d_{T,1}t_n + d_{T,2}t_{n+1} + \dots + d_{T,\delta_T}t_{n+\delta_T-1}), & n \leq -s_T, \\ h_{n+1} &= -(b_{H,1}h_n + b_{H,2}h_{n-1} + \dots + b_{H,\beta_H}h_{n-\beta_H+1}), & n \geq r_H, \\ h_{n-1} &= -(d_{H,1}h_n + d_{H,2}h_{n+1} + \dots + d_{H,\delta_H}h_{n+\delta_H-1}), & n \leq -s_H, \end{aligned}$$

where  $b_{T,i}$ ,  $d_{T,i}$ ,  $b_{H,i}$ , and  $d_{H,i}$  are given in (3.3b) and  $r_T$ ,  $s_T$ ,  $r_H$ , and  $s_H$  are defined in (3.4).

*Proof.* The proof is similar to the proof of Lemma 1 in [24].  $\square$

Based on the recursion (3.8), we construct two low rank Toeplitz matrices  $\Delta F_T$  and  $\Delta F_H$  as

$$(3.9) \quad \Delta F_T = F_{T,1} + F_{T,2}, \quad \text{and} \quad \Delta F_H = F_{H,1} + F_{H,2},$$

where

$$F_{T,1} = \begin{bmatrix} t_N & t_{N-1} & \cdot & t_2 & t_1 \\ t_{N+1} & t_N & t_{N-1} & \cdot & t_2 \\ \cdot & t_{N+1} & t_N & \cdot & \cdot \\ t_{2N-2} & \cdot & \cdot & \cdot & t_{N-1} \\ t_{2N-1} & t_{2N-2} & \cdot & t_{N+1} & t_N \end{bmatrix},$$

$$F_{T,2} = \begin{bmatrix} t_{-N} & t_{-(N+1)} & \cdot & t_{-(2N-2)} & t_{-(2N-1)} \\ t_{-(N-1)} & t_{-N} & t_{-(N+1)} & \cdot & t_{-(2N-2)} \\ \cdot & t_{-(N-1)} & t_{-N} & \cdot & \cdot \\ t_{-2} & \cdot & \cdot & \cdot & t_{-(N+1)} \\ t_{-1} & t_{-2} & \cdot & t_{-(N-1)} & t_{-N} \end{bmatrix},$$

and  $F_{H,1}$  and  $F_{H,2}$  are similarly constructed by changing elements of  $F_{T,1}$  and  $F_{T,2}$  from  $t_n$  to  $h_n$ . The  $\Delta F_T$  and  $\Delta F_H$  are asymptotically equivalent to  $\Delta T$  and  $\Delta T_H$ , respectively, and we have the following lemma.

LEMMA 2. Let  $T$  and  $H$  be  $N \times N$  Toeplitz and Hankel matrices generated by  $T(z)$  and  $H(z)$  in (3.3) with the corresponding generating sequences satisfying (3.1) and (3.2). Then,

$$\|\Delta A - \Delta F\|_2 \leq O(|t_N| + |t_{-N}| + |h_N| + |h_{-N}|),$$

where  $\Delta A$  is defined in (3.7) and

$$\Delta F = \Delta F_T + J\Delta F_H$$

with  $\Delta F_T$  and  $\Delta F_H$  given by (3.9). Consequently,  $\Delta A$  is asymptotically equivalent to  $\Delta F$ .

*Proof.* The proof is similar to the proof of Lemma 2 in [25].  $\square$

With (3.8), we can easily determine upper bounds for the ranks of  $\Delta F_T$  and  $\Delta F_H$ , i.e.,

$$\text{rank}(\Delta F_T) \leq r_T + s_T \quad \text{and} \quad \text{rank}(\Delta F_H) \leq r_H + s_H.$$

Since both  $J$  and  $P$  are full rank matrices, the rank of  $P^{-1}\Delta F$  (or equivalently the number of outliers of  $P^{-1}A$ ) is bounded above by

$$(3.10) \quad \tilde{\eta} = r_T + s_T + r_H + s_H.$$

However, the bound  $\tilde{\eta}$  is not tight. A tighter bound is available according to the following theorem.

**THEOREM 2.** *Let  $T$  and  $H$  be  $N \times N$  Toeplitz and Hankel matrices generated by  $T(z)$  and  $H(z)$  in (3.3) with the corresponding generating sequences satisfying (3.1) and (3.2). The number of outliers of  $P^{-1}A$  is bounded by*

$$(3.11) \quad \eta = \max(r_T + \beta_H, r_H + \beta_T) + \max(s_T + \delta_H, s_H + \delta_T) - \eta_c,$$

where  $\eta_c$  is the number of common roots in  $B_T(z)D_T(z)$  and  $B_H(z)D_H(z)$ .

*Proof.* We first focus on the case that all roots of  $B_T(z)$ ,  $D_T(z)$ ,  $B_H(z)$ , and  $D_H(z)$  are simple. By applying the partial fractional expansion to  $A_T(z^{-1})/B_T(z^{-1})$  and  $C_T(z)/D_T(z)$  and determining the corresponding Toeplitz matrix for each term, we obtain a decomposition for  $T$ , i.e.,

$$T = T_{1,0} + \sum_{i=1}^{\beta_T} T_{1,i} + T_{2,0} + \sum_{i=1}^{\delta_T} T_{2,i}.$$

In the above expression,  $T_{1,i}$  and  $T_{2,i}$  are, respectively, lower and upper triangular Toeplitz matrices. If  $\alpha_T - \beta_T \geq 0$ ,  $T_{1,0}$  has a lower bandwidth  $\alpha_T - \beta_T$ . Otherwise, it is equal to zero. The  $T_{1,i}$ ,  $i \neq 0$ , corresponds to the Toeplitz matrix generated by a root of  $B_T(z^{-1})$ . The  $T_{2,i}$ ,  $0 \leq i \leq \delta_T$ , is similarly defined.

We construct  $F_{T,1,i}$  and  $F_{T,2,i}$  for  $T_{1,i}$  and  $T_{2,i}$  based on (3.9). Since the construction is linear, we have

$$\Delta F_T = F_{T,1,0} + \sum_{i=1}^{\beta_T} F_{T,1,i} + F_{T,2,0} + \sum_{i=1}^{\delta_T} F_{T,2,i}.$$

It is easy to verify that the elements of  $F_{T,1,0}$  and  $F_{T,2,0}$  are zeros except the northeast  $\max(\alpha_T - \beta_T, 0)$  and the southwest  $\max(\gamma_T - \delta_T, 0)$  diagonals, respectively. All remaining terms in  $\Delta F_T$  are rank one matrices. The  $\Delta F_H$  can be similarly decomposed as

$$\Delta F_H = F_{H,1,0} + \sum_{i=1}^{\beta_H} F_{H,1,i} + F_{H,2,0} + \sum_{i=1}^{\delta_H} F_{H,2,i},$$

where the elements of  $F_{H,1,0}$  and  $F_{H,2,0}$  are zeros except the northeast  $\max(\alpha_H - \beta_H, 0)$  and the southwest  $\max(\gamma_H - \delta_H, 0)$  diagonals, respectively, and all other terms are rank one matrices.

Let us examine the rank of  $\Delta F = \Delta F_T + J\Delta F_H$ . The ranks of  $F_{T,1,0} + JF_{H,1,0}$  and  $F_{T,2,0} + JF_{H,2,0}$  are clearly bounded by  $\max(\alpha_T - \beta_T, \alpha_H - \beta_H, 0)$  and  $\max(\gamma_T - \delta_T, \gamma_H - \delta_H, 0)$ , respectively. Since all other terms in  $\Delta F_T$  and  $\Delta F_H$  are rank one matrices, the rank of  $\Delta F$  is bounded above by

$$(3.12) \quad \beta_T + \beta_H + \delta_T + \delta_H + \max(\alpha_T - \beta_T, \alpha_H - \beta_H, 0) + \max(\gamma_T - \delta_T, \gamma_H - \delta_H, 0)$$

which is the same as  $\eta$  given in (3.11) with  $\eta_c = 0$ .

Now, suppose that  $B_T(z)D_T(z)$  and  $B_H(z)D_H(z)$  have  $\eta_c$  common roots. This implies four combinations. That is,  $B_T(z)$  and  $B_H(z)$ ,  $B_T(z)$  and  $D_H(z)$ ,  $D_T(z)$  and  $B_H(z)$ , or  $D_T(z)$  and  $D_H(z)$  have common roots. Without loss of generality, we assume that  $B_T(z)$  and  $B_H(z)$  have a common root  $\mu$  and that Toeplitz matrices  $T_{1,k}$



and  $JH_{1,k}$  are generated by this root. By postmultiplying  $F_{T,1,k}$ ,  $F_{H,1,k}$ ,  $F_{T,1,k} + JF_{H,1,k}$  with the lower triangular Toeplitz matrix  $L_\mu$  which has

$$[1, -\mu, 0, \dots, 0]^T$$

as the first column, the resulting matrices have only one nonzero column. Thus, the rank of  $\Delta F = \Delta F_T + J\Delta F_H$  is lower than (3.12) by one due to the root  $\mu$  shared by  $B_T(z)$  and  $B_H(z)$ .

As to the other three combinations, similar arguments hold with the following modifications. When  $D_T(z)$  and  $D_H(z)$  have common roots, we postmultiply  $F_{T,2,k} + JF_{H,2,k}$  by the corresponding upper triangular banded Toeplitz matrix constructed with respect to the common root. When  $B_T(z)$  and  $D_H(z)$  (or  $B_H(z)$  and  $D_T(z)$ ) have common roots, we examine the rank of

$$\Delta F_{T,1,k} + J\Delta F_{H,2,k}JJ = \Delta F_{T,1,k} + \Delta F_{H,2,k}^T J$$

by premultiplying an appropriate lower (or upper) triangular Toeplitz banded matrix.

Let us now focus on the case that  $B_T(z)$ ,  $D_T(z)$ ,  $B_H(z)$ , or  $D_H(z)$  has repeated roots which are common for both  $B_T(z)D_T(z)$  and  $B_H(z)D_H(z)$ . Without loss of generality, we assume that  $B_T(z)$  has  $k_T$  roots at  $\mu$  and that  $B_H(z)$  has  $k_H$  roots at  $\mu$ . Let  $F_{T,1,i}$ ,  $1 \leq i \leq k_T$ , and  $F_{H,1,j}$ ,  $1 \leq j \leq k_H$ , be constructed with respect to the repeated roots  $\mu$ . It can be shown that

$$\left( \sum_{i=1}^{k_T} F_{T,1,i} + \sum_{j=1}^{k_H} F_{H,1,i} \right) L_\mu^k, \quad k = \max(k_T, k_H),$$

has at most  $k$  nonzero columns. Therefore, the rank of  $\Delta F = \Delta F_T + J\Delta F_H$  is lower than (3.12) by  $\min(k_T, k_H)$  due to the repeated roots shared by  $B_T(z)$  and  $B_H(z)$ .  $\square$

**3.3. The clustering radius of  $P^{-1}A$ .** It is clear from the analysis in §3.2 that the number of outliers of  $P^{-1}A$  does not depend on the boundedness of  $\|A^{-1}\|_2$ . To examine the spectral clustering property of  $P^{-1}A$ , we restrict our discussion in this subsection to the case that  $\|A^{-1}\|_2$  exists and is bounded by a constant independent of the size  $N$  of  $A$ . Besides, it is also assumed that  $B_T(z)D_T(z)$  and  $B_H(z)D_H(z)$  have no common roots ( $\eta_c = 0$ ).

Since nonzero eigenvalues of  $P^{-1}A$  and  $A^{-1}\Delta A$  are related via

$$(3.13) \quad [\lambda(P^{-1}A)]^{-1} = \lambda(A^{-1}(A + \Delta A)) = 1 + \lambda(A^{-1}\Delta A),$$

the eigenvalues of  $P^{-1}A$  clustered around unity are equivalent to the eigenvalues of  $A^{-1}\Delta A$  clustered around zero. Besides, it is known from the proof of Theorem 2 that  $\Delta A$  is asymptotically equivalent to

$$(3.14) \quad \Delta F = \Delta F_T + J\Delta F_H = (F_{T,1} + F_{T,2}) + J(F_{H,1} + F_{H,2}),$$

at a rate of  $O(|t_N| + |t_{-N}| + |h_N| + |h_{-N}|)$ . Thus, we divide the discussion on the spectral clustering radius of  $A^{-1}\Delta A$  into two steps.

*Step 1.* Transform  $A$  and  $\Delta F$  into  $Q_A$  and  $\Delta Q_F$  whose eigenstructures are easier to analyze (Lemmas 3–5).

*Step 2.* Use the perturbation theory to determine the spectral clustering radius of  $A^{-1}\Delta A$  or, equivalently,  $P^{-1}A$  (Lemmas 6 and 7, and Theorem 3).

We first transform the generalized eigenvalue problem

$$\Delta F \mathbf{x} = \lambda A \mathbf{x}, \quad \Delta F = \Delta F_T + J \Delta F_H, \quad A = T + J T_H,$$

to another generalized eigenvalue problem

$$(3.15) \quad \Delta Q_F \tilde{\mathbf{x}} = \lambda Q_A \tilde{\mathbf{x}}, \quad \mathbf{x} = U_{D,T} U_{D,H} L_{B,T} L_{B,H} \tilde{\mathbf{x}},$$

where

$$(3.15a) \quad \Delta Q_F = (L_{B,T} \mathcal{U}_{B,H}^T) \Delta F (U_{D,T} U_{D,H} L_{B,T} L_{B,H}),$$

$$(3.15b) \quad Q_A = (L_{B,T} \mathcal{U}_{B,H}^T) A (U_{D,T} U_{D,H} L_{B,T} L_{B,H}).$$

In (3.15a) and (3.15b),  $\mathcal{U}_{B,H}$  is an  $N \times N$  upper triangular Toeplitz matrices generated by  $z^{\beta_H} B_H(z^{-1})$ , whereas all other matrices are defined in (3.5). The postmultiplication with  $U_{D,T} U_{D,H} L_{B,T} L_{B,H}$  in (3.15a) is to make the elements of  $\Delta Q_F$  zero except the first and last several columns as described in Lemma 3. The premultiplication with  $L_{B,T} \mathcal{U}_{B,H}^T$  and the postmultiplication with  $U_{D,T} U_{D,H}$  in (3.15b) is used to simplify the structure of  $Q_A$  so that the elements in the four corner blocks of  $Q_A$  do not change with  $N$ , as shown in Lemma 4. An explanation for introducing the matrix  $\mathcal{U}_{B,H}$  will be given after the proof of Lemma 4.

LEMMA 3. *Let  $T$  and  $H$  be  $N \times N$  Toeplitz and Hankel matrices generated by  $T(z)$  and  $H(z)$  in (3.3) with the corresponding generating sequences satisfying (3.1) and (3.2). The elements of  $\Delta Q_F$  are zeros except the first  $s_0$  and last  $r_0$  columns, where*

$$s_0 = \max(s_T + \delta_H, s_H + \delta_T), \quad r_0 = \max(r_T + \beta_H, r_H + \beta_T).$$

*Proof.* Recall from (3.9) that  $\Delta F_T = F_{T,1} + F_{T,2}$  and

$$(F_{T,1})_{i,j} = t_{N+i-j}, \quad (F_{T,2})_{i,j} = t_{-N+i-j}.$$

The  $(i, j)$  element of  $F_{T,1} U_{D,T} U_{D,H} L_{B,T} L_{B,H}$  is

$$(3.16) \quad \sum_{k=1}^N \sum_{l=1}^N \sum_{m=1}^N \sum_{n=1}^N t_{N+i-k} d_{T,l-k} d_{H,m-l} b_{T,m-n} b_{H,n-j}.$$

If  $j \leq N - (r_T + \beta_H)$ , the above summation can be simplified as

$$(3.17) \quad \sum_{k'=0}^{\delta_T} \sum_{l'=0}^{\delta_H} \sum_{n'=0}^{\beta_H} \left( \sum_{m'=0}^{\beta_T} t_{N+i+k'+l'-m'-n'-j} b_{T,m'} \right) d_{T,k'} d_{H,l'} b_{H,n'} = 0,$$

where  $k' = l - k$ ,  $l' = m - l$ ,  $m' = m - n$ ,  $n' = n - j$ , and the equality is due to (3.8). Similarly, the  $(i, j)$  element of  $F_{T,2} U_{D,T} U_{D,H} L_{B,T} L_{B,H}$  can be simplified as

$$\sum_{l'=0}^{\delta_H} \sum_{m'=0}^{\delta_T} \sum_{n'=0}^{\beta_H} \left( \sum_{k'=0}^{\delta_T} t_{-N+i+k'+l'-m'-n'-j} d_{T,k'} \right) d_{H,l'} b_{T,m'} b_{H,n'} = 0,$$

for  $j > s_T + \delta_H$ . Thus, the elements of  $\Delta F_T U_{D,T} U_{D,H} L_{B,T} L_{B,H}$  are zeros except the first  $s_T + \delta_H$  and last  $r_T + \beta_H$  columns. We can argue in a similar fashion that

the elements of  $\Delta F_H U_{D,T} U_{D,H} L_{B,T} L_{B,H}$  are zeros except the first  $s_H + \delta_T$  and last  $r_H + \beta_T$  columns. Then, it is clear that the elements of  $\Delta Q_F$  are zeros except the first  $s_0$  and last  $r_0$  columns, and the proof is completed.  $\square$

According to Lemma 3, the rank space of  $Q_A^{-1} \Delta Q_F$  is contained in

$$\mathcal{R} = \{ \mathbf{v} \in R^N \mid v_n = 0, s_0 < n \leq N - r_0 \}.$$

Therefore, the nonzero eigenvalues of  $Q_A^{-1} \Delta Q_F$  only depend on the northwest  $s_0 \times s_0$ , the northeast  $s_0 \times r_0$ , the southwest  $r_0 \times s_0$ , and the southeast  $r_0 \times r_0$  blocks of  $Q_A$  and  $\Delta Q_F$ . The structures of the four corner blocks of  $Q_A$  and  $\Delta Q_F$  are stated in Lemmas 4 and 5, respectively.

LEMMA 4. *Let  $T$  and  $H$  be  $N \times N$  Toeplitz and Hankel matrices generated by  $T(z)$  and  $H(z)$  in (3.3) with the corresponding generating sequences satisfying (3.1) and (3.2). The elements in the northwest  $s_0 \times s_0$ , northeast  $s_0 \times r_0$ , southwest  $r_0 \times s_0$ , and southeast  $r_0 \times r_0$  blocks of  $Q_A$  do not change for sufficiently large  $N$ .*

*Proof.* With the relation  $A = T + JT_H$ , the  $Q_A$  can be written as

$$Q_A = Q_T + Q_H$$

where

$$\begin{aligned} Q_T &= (L_{B,T} \mathcal{U}_{B,H}^T) T (U_{D,T} U_{D,H} L_{B,T} L_{B,H}), \\ Q_H &= (L_{B,T} \mathcal{U}_{B,H}^T) J T_H (U_{D,T} U_{D,H} L_{B,T} L_{B,H}). \end{aligned}$$

By using (3.5), the fact that  $\mathcal{U}_{B,H}^T$  is a lower triangular Toeplitz matrix, and the commutative property of the matrix product among lower (or upper) triangular Toeplitz matrices, we obtain

$$Q_T = \mathcal{U}_{B,H}^T (L_{A,T} U_{D,T} + L_{B,T} U_{C,T}) U_{D,H} L_{B,T} L_{B,H},$$

which is a product of lower and upper triangular banded Toeplitz matrices. Thus, the elements in the corresponding four corner blocks of  $Q_T$  do not change for sufficiently large  $N$ .

To examine elements in the four corner blocks of  $Q_H$ , we use the relation

$$(3.18) \quad L_{B,T} \mathcal{U}_{B,H}^T J = J J L_{B,T} J J \mathcal{U}_{B,H}^T J = J L_{B,T}^T \mathcal{U}_{B,H},$$

and rewrite  $Q_H$  as

$$(3.19) \quad Q_H = J L_{B,T}^T (\mathcal{U}_{B,H} T_H U_{D,H}) U_{D,T} L_{B,T} L_{B,H}.$$

Let us decompose  $\mathcal{U}_{B,H}$  into matrices consisting of its north and south blocks, respectively, i.e.,

$$\mathcal{U}_{B,H} = W_N + W_S,$$

where  $W_N$  (or  $W_S$ ) consists of the first  $N - \beta_H$  (or last  $\beta_H$ ) rows of  $\mathcal{U}_{B,H}$  and zeros elsewhere. Since the first  $N - \beta_H$  rows of  $\mathcal{U}_{B,H}$  are the same as the last  $N - \beta_H$  rows of  $L_{B,H}$ , we know that

$$\tilde{W}_N = (W_N T_H U_{D,H}) U_{D,T} L_{B,T} L_{B,H}$$

has its last  $\beta_H$  rows equal to zero and first  $N - \beta_H$  rows equal to the last  $N - \beta_H$  rows of

$$\begin{aligned} G &= (L_{B,H}T_H U_{D,H}) U_{D,T}L_{B,T}L_{B,H} \\ &= (L_{A,H}U_{D,H} + L_{B,H}U_{C,H}) U_{D,T}L_{B,T}L_{B,H}. \end{aligned}$$

The elements in the four corner blocks of  $JL_{B,T}^T G$  do not change for sufficiently large  $N$  since it is a product of lower and upper banded triangular Toeplitz matrices. Consequently, the elements in the corresponding four corner blocks of

$$JL_{B,T}^T \tilde{W}_N = JL_{B,T}^T (W_N T_H U_{D,H}) U_{D,T}L_{B,T}L_{B,H}$$

do not change with  $N$ . Besides, since  $U_{B,H}$  is upper-triangular, the elements of  $W_S = U_{B,H} - W_N$  are zeros except the southeast  $\beta_H \times \beta_H$  block. It can be shown directly by matrix multiplication that the elements in the four corner blocks of

$$JL_{B,T}^T (W_S T_H U_{D,H}) U_{D,T}L_{B,T}L_{B,H}$$

do not change with  $N$ , and the proof is completed.  $\square$

With the above proof, it is easier to explain the need for introducing the premultiplying matrix  $U_{B,H}^T$  in transformation (3.15). First, it has to be a lower triangular Toeplitz so that it commutes with  $L_{B,T}$ . Second, in order to move the time-reversal operator  $J$  in  $Q_H$  to the front as in (3.18), its transpose has to behave similarly as  $L_{B,H}$  so that its multiplication with  $JL_{B,H}^{-1}$  relates to a banded matrix. The  $U_{B,H}^T$  satisfies both conditions, and is then used in transformation (3.15).

LEMMA 5. *Let  $T$  and  $H$  be  $N \times N$  Toeplitz and Hankel matrices generated by  $T(z)$  and  $H(z)$  in (3.3) with the corresponding generating sequences satisfying (3.1) and (3.2). The corresponding four corner blocks of  $\Delta Q_F$  converge to  $\overline{Q}_{NW}$ ,  $\overline{Q}_{NE}$ ,  $\overline{Q}_{SW}$ , and  $\overline{Q}_{SE}$ , respectively, where  $\overline{Q}_{NE}$  is the the northeast  $s_0 \times r_0$  block of*

$$(L_{B,T}U_{B,H}^T) F_{T,1} (U_{D,T}U_{D,H}L_{B,T}L_{B,H}),$$

$\overline{Q}_{SW}$  is the the southwest  $r_0 \times s_0$  block of

$$(L_{B,T}U_{B,H}^T) F_{T,2} (U_{D,T}U_{D,H}L_{B,T}L_{B,H}),$$

$\overline{Q}_{NW}$  is the the northwest  $s_0 \times s_0$  block of

$$(L_{B,T}U_{B,H}^T) JF_{H,2} (U_{D,T}U_{D,H}L_{B,T}L_{B,H}),$$

and  $\overline{Q}_{SE}$  is the the southeast  $r_0 \times r_0$  block of

$$(L_{B,T}U_{B,H}^T) JF_{H,1} (U_{D,T}U_{D,H}L_{B,T}L_{B,H}).$$

The elements of  $\overline{Q}_{NW}$ ,  $\overline{Q}_{NE}$ ,  $\overline{Q}_{SW}$ , and  $\overline{Q}_{SE}$  do not change for sufficiently large  $N$ .

*Proof.* Recall that

$$\Delta F = \Delta F_T + J\Delta F_H = (F_{T,1} + F_{T,2}) + J(F_{H,1} + F_{H,2}).$$

Let us define

$$\tilde{T}_1 = F_{T,1}U_{D,T}U_{D,H}L_{B,T}L_{B,H} \quad \text{and} \quad \tilde{T}_2 = F_{T,2}U_{D,T}U_{D,H}L_{B,T}L_{B,H}.$$

With (3.16), the  $(i, j)$  element of  $\tilde{T}_1$  is bounded by

$$\begin{aligned} & \sum_{k'=0}^{\delta_T} \sum_{l'=0}^{\delta_H} \sum_{m'=0}^{\beta_T} \sum_{n'=0}^{\beta_H} |t_{N+i+k'+l'-m'-n'-j}| |d_{T,k'}| |d_{H,l'}| |b_{T,m'}| |b_{H,n'}| \\ & \leq \sum_{m'=0}^{\beta_T} |b_{T,m'}| \sum_{n'=0}^{\beta_H} |b_{H,n'}| \sum_{k'=0}^{\delta_T} |d_{T,k'}| \sum_{l'=0}^{\delta_H} |d_{H,l'}| \max_{-(\beta_T+\beta_H) \leq n \leq (\delta_T+\delta_H)} |t_{N+i-j+n}|. \end{aligned}$$

To determine an upper bound for  $\sum_{m=0}^{\beta_T} |b_{T,m}|$ , we factorize  $B_T(z^{-1})$  as

$$B_T(z^{-1}) = (1 - r_1 z^{-1})(1 - r_2 z^{-1}) \cdots (1 - r_{\beta_T} z^{-1}).$$

A direct consequence of (3.1) is that  $|r_i| < 1, 1 \leq i \leq \beta_T$ , so that

$$|b_{T,m}| \leq \binom{\beta_T}{m} (\max |r_i|)^m \leq \binom{\beta_T}{m}, \quad \text{where} \quad \binom{\beta_T}{m} \equiv \frac{\beta_T!}{(\beta_T - m)!m!}.$$

Therefore, we obtain

$$(3.20) \quad \sum_{m=0}^{\beta_T} |b_{T,m}| \leq \sum_{m=0}^{\beta_T} \binom{\beta_T}{m} = 2^{\beta_T}.$$

Similarly, we can derive that

$$(3.21) \quad \sum_{l=0}^{\beta_H} |b_{H,l}| \leq 2^{\beta_H}, \quad \sum_{k=0}^{\delta_T} |d_{T,k}| \leq 2^{\delta_T}, \quad \sum_{l=0}^{\delta_H} |d_{H,l}| \leq 2^{\delta_H}.$$

Thus, the  $(i, j)$  element of  $\tilde{T}_1$  is bounded by

$$(3.22) \quad 2^{\beta_T+\beta_H+\delta_T+\delta_H} \max_{-(\beta_T+\beta_H) \leq n \leq (\delta_T+\delta_H)} |t_{N+i-j+n}|.$$

We can see from (3.22) that the elements in the corresponding northeast, northwest, southeast, and southwest blocks of  $\tilde{T}_1$  are bounded by  $O(|t_0|), O(|t_N|), O(|t_N|)$ , and  $O(|t_{2N}|)$ , respectively. The same result holds for  $L_{B,T} \mathcal{U}_{B,H}^T \tilde{T}_1$ , since  $L_{B,T} \mathcal{U}_{B,H}^T$  is a lower triangular banded Toeplitz matrix with 2-norm of  $O(1)$ . In addition, we can verify that the elements in the northeast block of  $L_{B,T} \mathcal{U}_{B,H}^T \tilde{T}_1$  (i.e.,  $\bar{Q}_{NE}$ ) are fixed for sufficiently large  $N$ , which is due to the banded structures of  $\mathcal{U}_{B,H}^T, U_{D,T}, U_{D,H}, L_{B,T}$ , and  $L_{B,H}$ . Similarly, we can argue that the elements in the corresponding northeast, northwest, southeast, and southwest blocks of  $L_{B,T} \mathcal{U}_{B,H}^T \tilde{T}_2$  are bounded by  $O(|t_{-2N}|), O(|t_{-N}|), O(|t_{-N}|)$ , and  $O(|t_0|)$ , respectively, and the elements in the southwest corner block (i.e.,  $\bar{Q}_{SW}$ ) do not change for large  $N$ . Since  $T$  and  $T_H$  are both rational Toeplitz, the same results also hold for

$$(L_{B,T} \mathcal{U}_{B,H}^T) (JF_{H,1} U_{D,T} U_{D,H} L_{B,T} L_{B,H}), \quad (L_{B,T} \mathcal{U}_{B,H}^T) (JF_{H,2} U_{D,T} U_{D,H} L_{B,T} L_{B,H}),$$

and the proof is completed.  $\square$

With the above lemma, we change the corresponding four corner blocks of  $\Delta Q_F$  to their asymptotic values, and denote the resulting matrix by  $\Delta \bar{Q}_F$ , i.e.,

$$(3.23) \quad \Delta \bar{Q}_F = \begin{bmatrix} \bar{Q}_{NW} & 0 & \bar{Q}_{NE} \\ \bar{Q}_{W} & 0 & \bar{Q}_{E} \\ \bar{Q}_{SW} & 0 & \bar{Q}_{SE} \end{bmatrix},$$

where  $Q_W$  (or  $Q_E$ ) are the middle  $N - (r_0 + s_0)$  rows in the first  $s_0$  (or the last  $r_0$ ) columns of  $\Delta Q_F$ . Thus, the matrix  $\Delta Q_F - \Delta \bar{Q}_F$  converges to the zero matrix at a rate bounded by

$$(3.24) \quad \|\Delta Q_F - \Delta \bar{Q}_F\|_2 \leq O(|t_N| + |t_{-N}| + |h_N| + |h_{-N}|).$$

Since the nonzero eigenvalues of  $Q_A^{-1} \Delta \bar{Q}_F$  only depend on elements in the corresponding four corner blocks of  $Q_A$  and  $\Delta \bar{Q}_F$ , which do not change with  $N$ , the framework of the perturbation analysis for eigenvalues can be conveniently applied as described in the following.

Due to transformation (3.15), the eigenvalues of  $A^{-1} \Delta A$  are those of  $Q_A^{-1} \Delta Q_A$  where

$$\Delta Q_A = (L_{B,T} \mathcal{U}_{B,H}^T) \Delta A (U_{D,T} U_{D,H} L_{B,T} L_{B,H}).$$

We can view  $\Delta Q_A$  as the sum of  $\Delta \bar{Q}_F$  and a perturbation matrix

$$\Delta Q_E \equiv \Delta Q_A - \Delta \bar{Q}_F = (\Delta Q_A - \Delta Q_F) + (\Delta Q_F - \Delta \bar{Q}_F).$$

To determine a bound on  $\|\Delta Q_E\|_2$ , we have

$$(3.25) \quad \|\Delta Q_E\|_2 \leq \|\Delta Q_A - \Delta Q_F\|_2 + \|\Delta Q_F - \Delta \bar{Q}_F\|_2.$$

By using Lemma 2 and the boundedness of

$$\|U_{D,T}\|_2, \|U_{D,H}\|_2, \|L_{B,T}\|_2, \|L_{B,H}\|_2, \quad \text{and} \quad \|\mathcal{U}_{B,H}^T\|_2,$$

which is implied from (3.20) and (3.21), it is clear that

$$\|\Delta Q_A - \Delta Q_F\|_2 \leq O(|t_N| + |t_{-N}| + |h_N| + |h_{-N}|).$$

The above equation, (3.24), and (3.25), give a bound on  $\|\Delta Q_E\|_2$ , i.e.,

$$\|\Delta Q_E\|_2 \leq O(|t_N| + |t_{-N}| + |h_N| + |h_{-N}|).$$

In addition, we know from (3.15) that

$$(3.26) \quad \|Q_A^{-1}\|_2 \leq \|L_{B,H}^{-1}\|_2 \|L_{B,T}^{-1}\|_2 \|U_{D,H}^{-1}\|_2 \|U_{D,T}^{-1}\|_2 \|A^{-1}\|_2 \|\mathcal{U}_{B,H}^{-T}\|_2 \|L_{B,T}^{-1}\|_2.$$

Since all roots of the generating function for lower (or upper) triangular banded matrices in the above inequality are inside (or outside) the unit circle due to (3.1), all matrix norms in the right-hand side of (3.26) are bounded by a constant independent of  $N$  [23], [25]. Therefore,  $\|Q_A^{-1}\|_2 = O(1)$  and we obtain the following lemma.

LEMMA 6. *Let  $T$  and  $H$  be  $N \times N$  Toeplitz and Hankel matrices generated by  $T(z)$  and  $H(z)$  in (3.3) with the corresponding generating sequences satisfying (3.1) and (3.2). Then*

$$\|Q_A^{-1} \Delta Q_E\|_2 \leq \varepsilon = O(|t_N| + |t_{-N}| + |h_N| + |h_{-N}|)$$

for sufficiently large  $N$ .

Note that  $\Delta \bar{Q}_F$  has at most  $r_0 + s_0$  nonzero columns, which is equal to  $\eta$  in (3.10) with  $\eta_c = 0$ . The rank  $\eta_r$  of  $\Delta \bar{Q}_F$  is therefore bounded by

$$(3.27) \quad \eta_r \leq \eta \leq \tilde{\eta},$$

where  $\eta$  and  $\tilde{\eta}$  are defined in (3.10) and (3.11). We arrange the eigenvalues of  $Q_A^{-1}\Delta\bar{Q}_F$  in descending order, i.e.,  $|\lambda_n| \geq |\lambda_{n+1}|$ , and denote the corresponding normalized right-hand and left-hand eigenvectors by  $\mathbf{x}_1, \mathbf{x}_2, \dots, \mathbf{x}_N$  and  $\mathbf{y}_1, \mathbf{y}_2, \dots, \mathbf{y}_N$ , respectively. Since the rank of  $\Delta\bar{Q}_F$  is  $\eta_r$ ,  $\lambda_n = 0$  for  $\eta_r < n \leq N$ . We choose vectors  $\mathbf{x}_n$  with  $\eta_r < n \leq N$  to be orthogonal for different values of  $n$ . We also define

$$(3.28) \quad s_n = \mathbf{y}_n^H \mathbf{x}_n, \quad 1 \leq n \leq N.$$

The reciprocal of  $s_n$  is usually known as the condition of the eigenvalue  $\lambda_n$  [15], which is bounded uniformly by a constant independent of  $N$  as stated in Lemma 7.

LEMMA 7. *Let  $T$  and  $H$  be  $N \times N$  Toeplitz and Hankel matrices generated by  $T(z)$  and  $H(z)$  in (3.3) with the corresponding generating sequences satisfying (3.1) and (3.2). Then, the  $|s_m^{-1}|, 1 \leq m \leq \eta_r$ , of  $Q_A^{-1}\Delta\bar{Q}_F$  is bounded by a constant independent of  $N$ .*

*Proof.* According to (3.23), it is clear that the rank space of  $Q_A^{-1}\Delta\bar{Q}_F$  is contained in

$$\mathcal{R} = \{\mathbf{v} \in R^N \mid v_n = 0, s_0 < n \leq N - r_0\},$$

where

$$s_0 = \max(s_T + \delta_H, s_H + \delta_T), \quad r_0 = \max(r_T + \beta_H, r_H + \beta_T).$$

All nonzero eigenvalues of  $Q_A^{-1}\Delta\bar{Q}_F$  can be determined by considering the generalized eigenvalue problem in the subspace  $\mathcal{R}$ . Since all elements in the corresponding four corner blocks of  $Q_A$  and  $\Delta\bar{Q}_F$  do not change with  $N$ , the boundedness of  $|s_m^{-1}|, 1 \leq m \leq \eta_r$ , is implied, and the proof is completed.  $\square$

The eigenvalues of

$$Q_A^{-1}\Delta Q_A = Q_A^{-1}\Delta\bar{Q}_F + Q_A^{-1}\Delta Q_E$$

can be estimated from those of  $Q_A^{-1}\Delta\bar{Q}_F$  through perturbation theory. Since the norm of the perturbation matrix is equal to  $\varepsilon$  as given in Lemma 6, we denote the eigenvalues and the right-hand eigenvectors of the perturbed matrix  $Q_A^{-1}\Delta Q_A$  by  $\lambda_n(\varepsilon)$  and  $\mathbf{x}_n(\varepsilon)$ , respectively. According to perturbation theory for repeated eigenvalues [33], the eigenvectors  $\mathbf{x}_n(\varepsilon)$  with  $\eta_r < n \leq N$  must take the form

$$\mathbf{x}_n(\varepsilon) = \sum_{m=1}^{\eta_r} \frac{\xi_{mn}}{(\lambda_n - \lambda_m)s_m} \mathbf{x}_m + \sum_{m=\eta_r+1}^N g_{mn} \mathbf{x}_m + O(\varepsilon^2),$$

where  $\xi_{mn} = \mathbf{y}_m^H Q_A^{-1}\Delta Q_E \mathbf{x}_n$ ,  $\lambda_n = 0$ ,  $g_{nn} = 1$ , and  $s_m$  defined in (3.28). Due to the construction, we know that

$$\|\mathbf{x}_n(\varepsilon)\|_2 \geq \|\mathbf{x}_n\|_2 = 1.$$

The factor  $|\xi_{mn}|$  is bounded by

$$|\xi_{mn}| = |\mathbf{y}_m^H Q_A^{-1}\Delta Q_E \mathbf{x}_n| \leq \|\mathbf{y}_m\|_2 \|Q_A^{-1}\Delta Q_E\|_2 \|\mathbf{x}_n\|_2 \leq \varepsilon.$$

The  $|s_m^{-1}|, 1 \leq m \leq \eta_r$ , is also bounded due to Lemma 7. The magnitude of  $\lambda_n(\varepsilon), \eta_r < n \leq N$ , of  $Q_A^{-1}\Delta Q_A$  is approximated by

$$|\lambda_n(\varepsilon)| = \frac{\|Q_A^{-1}(\Delta\bar{Q}_F + \Delta Q_E)\mathbf{x}_n(\varepsilon)\|_2}{\|\mathbf{x}_n(\varepsilon)\|_2}$$

$$\begin{aligned} &\leq \sum_{m=1}^{\eta_r} \frac{\|\xi_{mn} Q_A^{-1} \Delta \bar{Q}_F \mathbf{x}_m\|_2}{|\lambda_m s_m| \|\mathbf{x}_n(\varepsilon)\|_2} + \|Q_A^{-1} \Delta Q_E\|_2 \\ &\leq \sum_{m=1}^{\eta_r} \frac{\varepsilon}{|s_m|} + \varepsilon. \end{aligned}$$

Since  $\eta_r \leq \eta$  as given by (3.27), we conclude that  $Q_A^{-1} \Delta Q_A$  (or  $A^{-1} \Delta A$ ) has at least  $N - \eta$  eigenvalues bounded by

$$\epsilon_Q = O(|t_N| + |t_{-N}| + |h_N| + |h_{-N}|)$$

for sufficiently large  $N$ . With (3.13), the above results are summarized in the following theorem.

**THEOREM 3.** *Let  $T$  and  $H$  be  $N \times N$  Toeplitz and Hankel matrices generated by  $T(z)$  and  $H(z)$  in (3.3) with the corresponding generating sequences satisfying (3.1) and (3.2). Besides,  $A = T + H$  has a bounded inverse, and  $B_T(z)D_T(z)$  and  $B_H(z)D_H(z)$  have no common roots. For sufficiently large  $N$ , there are at least  $N - \eta$  eigenvalues of  $P^{-1}A$ , where  $\eta$  is given in (3.11) with  $\eta_c = 0$ , confined in the disk centered at unity with radius  $\epsilon$  proportional to*

$$\epsilon = O(|t_N| + |t_{-N}| + |h_N| + |h_{-N}|).$$

**4. Numerical experiments.** We use four test problems, including symmetric and nonsymmetric  $T$  and  $T_H$ , to illustrate the analysis. For all Toeplitz-plus-Hankel systems  $A\mathbf{x} = \mathbf{b}$  to be solved in the experiments, we choose  $\mathbf{b} = (1, \dots, 1)^T$  and the zero initial guess.

**Test Problem 1.** Symmetric  $T$  and  $T_H$  with  $(\alpha_T, \beta_T, \gamma_T, \delta_T) = (1, 1, 1, 1)$  and  $(\alpha_H, \beta_H, \gamma_H, \delta_H) = (1, 2, 1, 2)$ .

The generating functions of  $T$  and  $T_H$  are chosen to be

$$\begin{aligned} T(z) &= \frac{0.5 + 0.7z^{-1}}{1 + 0.7z^{-1}} + \frac{0.5 + 0.7z}{1 + 0.7z}, \\ H(z) &= \frac{0.5 - 0.4z^{-1}}{(1 - 0.7z^{-1})(1 - 0.9z^{-1})} + \frac{0.5 - 0.4z}{(1 - 0.7z)(1 - 0.9z)}. \end{aligned}$$

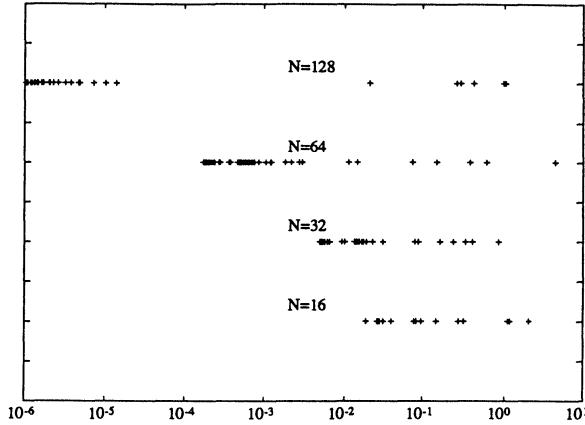


FIG. 1. The eigenvalue distribution of  $A^{-1}\Delta A$  for Test Problem 1.

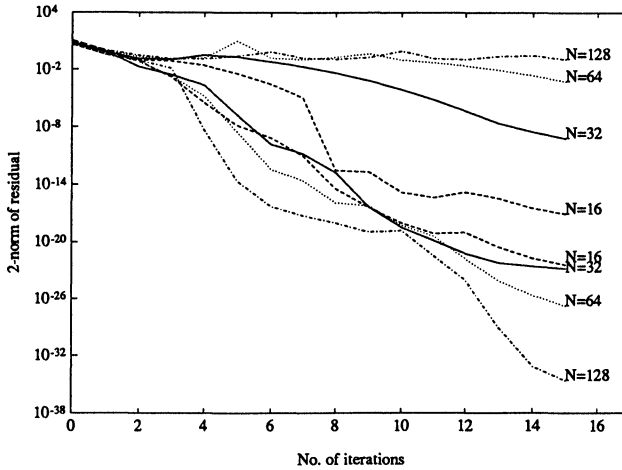


FIG. 2. The convergence history of the PCG method for Test Problem 1.

The eigenvalues of  $A^{-1} \Delta A$ , except those with magnitude less than  $10^{-6}$ , are plotted in Fig. 1. Although it is difficult to distinguish the outliers from the clustered eigenvalues for  $N \leq 64$ , we can see six outliers more easily for the case  $N = 128$ . The number of outliers is consistent with (3.11), where the last three terms are all equal to zero. The clustering radii  $\epsilon$ ,  $|t_N|$ , and  $|h_N|$  for different  $N$  are listed in Table 1. The values of  $\epsilon$  decrease at a rate of  $O(|t_N| + |h_N|)$ . The convergence history of the CG and PCG methods are plotted in Fig. 2. The upper four curves are those of the CG method whereas the lower four curves correspond to those of the PCG method. The preconditioning does accelerate the convergence rate of the CG method significantly. The convergence rate of the CG method becomes slower for larger  $N$ . In contrast, the PCG method converges faster as  $N$  becomes larger. It in fact converges in four ( $= \eta/2 + 1$ ) iterations asymptotically. The reason that it takes only  $\eta/2 + 1$  iterations for the PCG method to converge can be explained by the fact that that the outliers are related in pairs such that only  $\eta/2$  iterations are needed to eliminate the effects

of  $\eta$  outliers. A similar phenomenon has been reported in [22] for solving symmetric positive-definite Toeplitz systems with the PCG method.

**Test Problem 2.** Symmetric  $T$  with  $(\alpha_T, \beta_T, \gamma_T, \delta_T) = (1, 1, 1, 1)$  and nonsymmetric  $T_H$  with  $(\alpha_H, \beta_H, \gamma_H, \delta_H) = (0, 0, 1, 3)$ .

The generating functions of  $T$  and  $T_H$  are chosen to be

$$T(z) = \frac{0.5 + 0.3z^{-1}}{1 + 0.8z^{-1}} + \frac{0.5 + 0.3z}{1 + 0.8z}, \quad H(z) = \frac{0.5 - 0.4z}{(1 - 0.5z)(1 + 0.8z)^2}.$$

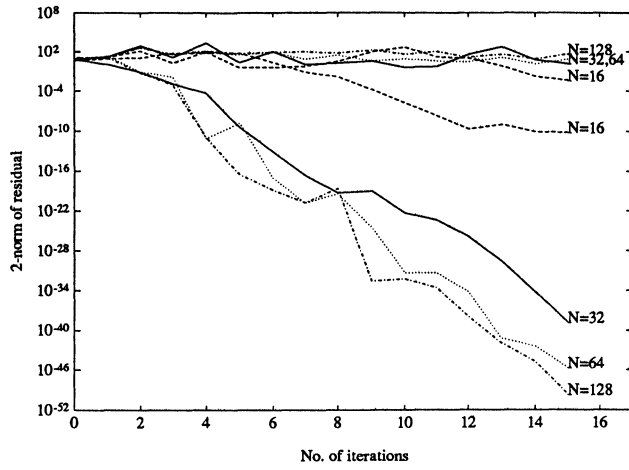


FIG. 3. The convergence history of the CGS method for Test Problem 2.

Note that  $B_T(z^{-1}) = 1 + 0.8z^{-1}$  and  $B_T(z)D_T(z) = (1 + 0.8z)^2$ . Since  $B_T(z)D_T(z)$  and  $D_H(z)$  have two common roots ( $\eta_c = 2$ ), we know that there are at most three outliers according to (3.11), which is confirmed numerically. The other eigenvalues of  $P^{-1}A$  are confined in the disk centered at unity with radius  $\epsilon$ . Since  $|h_{-N}| \gg |t_N| = |t_{-N}|$ ,  $\epsilon = O(|h_{-N}|)$ . The clustering radii  $\epsilon$ ,  $|t_N|$  and  $|h_{-N}|$  are listed in Table 2. We apply the CGS method to solve the Toeplitz-plus-Hankel system and plot the convergence history in Fig. 3. The lower and upper four curves are those of the CGS method with and without preconditioning, respectively. The preconditioned CGS method converges faster as  $N$  becomes larger, and converges in four iterations asymptotically. In contrast, the CGS method without preconditioning does not converge at all. Although the relation between the convergence rate of the CGS method and the spectrum of the iteration matrix is not clear, our numerical results show that the CGS method converges in a finite number of iterations if the iteration matrix has only a finite number of asymptotic distinct eigenvalues.

**Test Problem 3.** Nonsymmetric  $T$  with  $(\alpha_T, \beta_T, \gamma_T, \delta_T) = (1, 2, 0, 0)$  and nonsymmetric  $T_H$  with  $(\alpha_H, \beta_H, \gamma_H, \delta_H) = (1, 1, 0, 0)$ .

The generating functions of  $T$  and  $T_H$  are chosen to be

$$T(z) = \frac{1 - 0.9z^{-1}}{(1 + 0.5z^{-1})(1 + 0.8z^{-1})}, \quad H(z) = \frac{1 + 0.5z^{-1}}{1 - 0.7z^{-1}}.$$

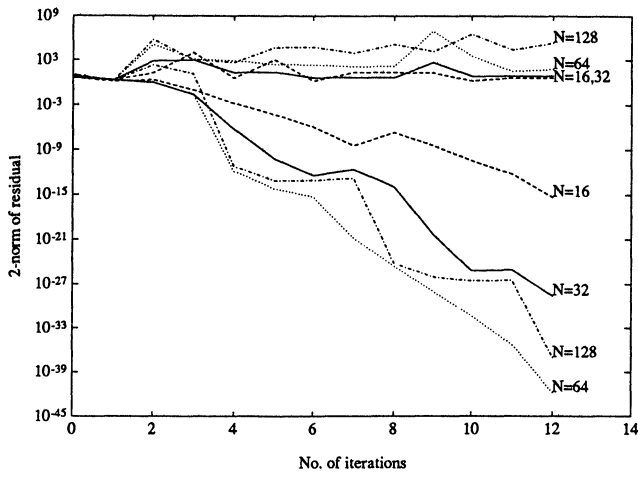


FIG. 4. The convergence history of the CGS method for Test Problem 3.

Theorem 2 predicts three outliers, which is confirmed by the experiment for large  $N$ . All other eigenvalues of  $P^{-1}A$  are confined in the disk centered at unity with radius  $\epsilon$ . The values of  $\epsilon$ ,  $|t_N|$ , and  $|h_{-N}|$  are listed in Table 3. Since  $|t_N| \gg |h_N|$ ,  $\epsilon$  decreases at a rate of  $O(|t_N|)$ . The convergence history of the CGS method with and without preconditioner is plotted in Fig. 4. They correspond to the lower and upper four curves, respectively. Again, we observe that the CGS method converges in four iterations for large  $N$  whereas the CGS method, without preconditioning, does not converge at all.

**Test Problem 4.** Symmetric nonrational  $T$  and  $T_H$ .

The preconditioner  $P$  is applied to nonrational Toeplitz-plus-Hankel matrices, where  $T$  and  $T_H$  are symmetric Toeplitz matrices with generating sequences

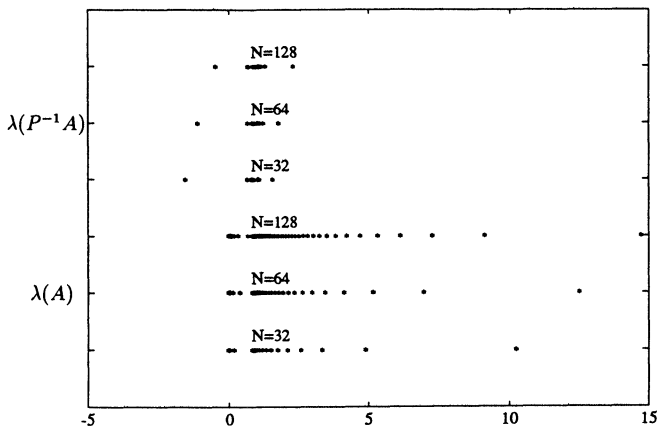


FIG. 5. The eigenvalue distribution of  $A$  and  $P^{-1}A$  for Test Problem 4.

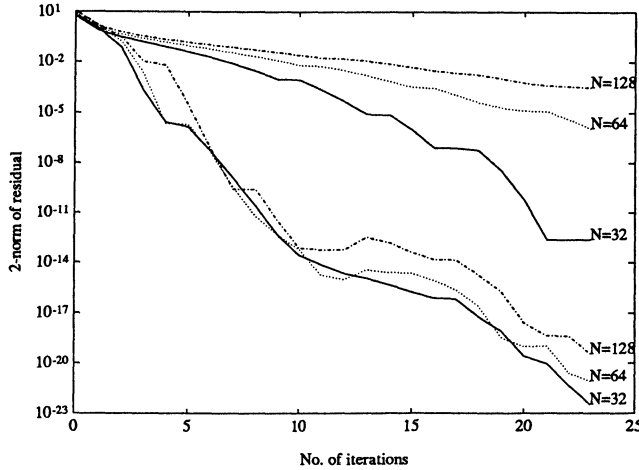


FIG. 6. The convergence history of the CGN method for Test Problem 4.

$$t_n = \frac{1}{|n| + 1} \quad \text{and} \quad h_n = \frac{1}{(|n| + 1)^{1.1}},$$

respectively. The eigenvalues of  $A$  and  $P^{-1}A$  are plotted in Fig. 5. Although the spectral properties of  $P^{-1}A$  are beyond our analysis in §3, the preconditioner  $P$  still provides a good spectral clustering property. We apply the CGN method to solve the preconditioned system  $P^{-1}Ax = P^{-1}b$ , and plot the convergence history of this method with and without preconditioning in Fig. 6, where they correspond to the lower and upper three curves, respectively. It is clear that the CGN method with preconditioner  $K$  converges faster than without preconditioning.

**Test Problem 5.** Ill-conditioned  $T$  and  $T_H$ .

The generating functions of  $T$  and  $T_H$  are chosen to be

$$T(z) = \epsilon_1 + z^{-1} \quad H(z) = \epsilon_2 + z,$$

where  $\epsilon_1$  and  $\epsilon_2$  denote some small constants. The  $A$  is ill conditioned when both  $\epsilon_1$  and  $\epsilon_2$  are close to zero. Although  $P^{-1}A$  is ill conditioned, it has two distinct eigenvalues, i.e., one outlier close to zero and  $(N - 1)$  eigenvalues repeated at one. The number of outliers is in fact less than the bound given in Theorem 2. By applying the CGS method to solve the preconditioned system, we observe that the 2-norm of the residual is reduced significantly in two iterations for various values of  $\epsilon_1$ ,  $\epsilon_2$ , and  $N$ .

**5. Conclusion.** In this research, we generalized the circulant preconditioning technique from Toeplitz to Toeplitz-plus-Hankel matrices. When the Toeplitz and Hankel matrices are both generated by rational functions, we proved that the eigenvalues of the preconditioned matrix are clustered around one, except for a finite number of outliers depending on the order of the generating functions, and that the clustering radius is proportional to the magnitudes of the last elements in Toeplitz and Hankel matrices. With the spectral properties, an  $N \times N$  rational Toeplitz-plus-Hankel systems can be solved by preconditioned iterative methods with  $O(N \log N)$  operations. Although our discussion focused on real Toeplitz-plus-Hankel systems, the generalization to complex Toeplitz-plus-Hankel systems can be done in a straightforward way.
